Course description and target audience

The Fourth Mid-Atlantic Neurocritical Care Symposium will highlight evidence-based practices and emerging innovations in prehospital triage, resuscitation, transport, and critical care management of patients with traumatic brain injury, stroke, intracranial hemorrhage, status epilepticus, hepatic encephalopathy, and out-of-hospital cardiac arrest. Through expert lectures, debates, and interactive exchange, participants will gain insights into optimizing neurologic outcomes across diverse clinical scenarios and care settings.

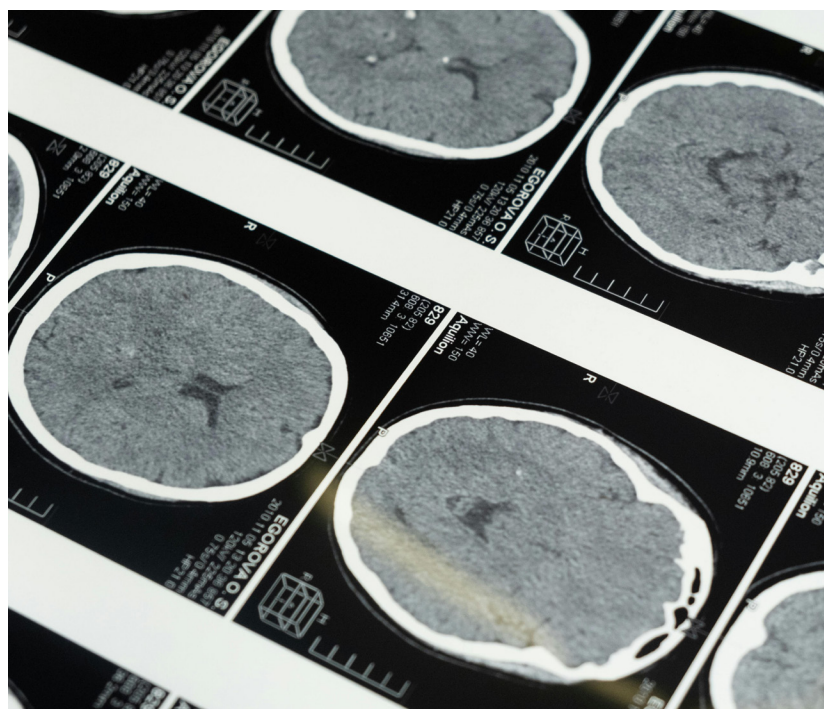
