Atrial Fibrillation - A concise review of 2023 ACC/AHA/ACCP/HRS guidelines; Combining Biomarkers and Imaging for Assessment of Cardiovascular Disease Risk and Subclinical Myocardial Impairment in Asymptomatic Patients

## Purpose or Objectives: At the conclusion of this activity, the participant will be able to:

- 1 Understand the key updates in the 2023 ACC/AHA/ACCP/HRS guidelines for the diagnosis and management of atrial fibrillation.
- 1 Differentiate between the roles of rate and rhythm control strategies, including the evidence supporting early rhythm control in selected patients.
- 2 Apply guideline-directed recommendations for anticoagulation, lifestyle modification, and risk factor management in patients with atrial fibrillation.
- 2 Identify key biomarkers (e.g., hs-cTn, NT-proBNP, hs-CRP) and imaging modalities used in the early detection of subclinical myocardial dysfunction and cardiovascular disease in asymptomatic individuals.
- 3 Evaluate the clinical utility and prognostic value of combining biomarker and imaging data to enhance cardiovascular risk stratification beyond traditional scoring systems in asymptomatic patients.
- 4 Integrate biomarker and imaging findings into clinical decision-making algorithms to guide early preventive interventions and optimize long-term outcomes in patients at risk for developing symptomatic cardiovascular disease
