Overview

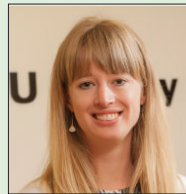

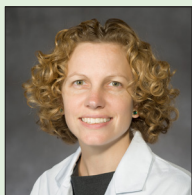
